MEMORANDUM OF UNDERSTANDING

This agreement is made on this ...26th... Day of November..., 2015 between The Institute of Chartered Financial Analysts of India University, Tripura (in short ICFAI University, Tripura) represented by the REGISTRAR of the University (hereinafter called "The Licensee") on the one part and the Krishna Kanta Handiqui State Open University (in short KKHSOU), Guwahati, represented by its REGISTRAR (hereinafter called "The Licensor") on the other part.

Whereas, the Licensee wishes to make use of the instructional material of KKHSOU, Guwahati in print format designed and developed for the Teacher Education Programme, namely Diploma in Elementary Education (D.El.Ed, in short) by way of acquisition of reproduction right and supplying them to the learners of the Teacher Education Programme offered by the Licensee and the Licensor wishes to grant license for such purposes.

The Licensee and Licensor herewith AGREE on the following terms:


- I. The licensee will use the instructional material designed and developed by the Licensor as specified in this agreement for the academic programmes/courses offered by the Licensee for an initial period of three years, from the date of this agreement.
- II. The Licensor hereby grants to the Licensee acquisition of reproduction right of the following Self Learning Materials (SLMs) in English and Bengali (Optional paper only) of the D.El.Ed programme for their use by reproducing the same for the learners enrolled with the Licensee University i.e, The ICFAI University, Tripura only and a copy of the relevant material forms the part and parcel of this agreement document.

III. The following terms and condition govern the license being granted herewith :-

- The Licensee shall seek the reproduction rights of the complete course material. The Licensor will supply to the licensee a hard & a soft copy of all course materials of the said programmes to be used by the Licensee as a copy for further processing and printing at the cost to be borne by Licensee concerned.
- No Change in the text, including the print cover page, shall be made by the Licensee when the course material is reprinted except for the following :-
- The print line, mentioning the name of the press where it has been printed should be substituted by a print line giving the name of the press which shall reprint it.
- Due acknowledgement of the Licensor made by the Licensee, at a prominent place in each of the book.
- The updating of data and/or error rectification as addendum/errata on separate sheet with prior permission of the Licensor.
- Printing of logo of the Licensee in addition to that of the Licensor.
- No translation of material into any other language be permissible under this agreement. The Licensee may go for a separate agreement in case it intends to translate the material.
- The Licensee, while reprinting the material shall ensure that the print quality of the material is as per standards of Licensor's study material in respect of quality of paper and printing, cover printing etc.
- A printed copy of the each reproduced self learning material of the D.El.Ed programme shall be provided to the Licensor by the Licensee immediately after print for record.
- The Licensee, while using the printed instructional material of the Licensor, may also use the supportive audio-visual cassettes prepared by the Licensor (if any).



- IV. Any breach of this agreement shall render the license null and void. In such circumstances, the Licensee shall destroy all reprint copies made and show proof of such destruction by submitting to the Licensor a certificate of destruction, and refrain from making use of the reproduced material.
- V. The License shall be terminated, if it is found that the Licensee University is not using the license for the given purpose.
- VI. The License shall be terminated, if it is found that the Licensee University in connivance with the printer is selling the material in the market or making the material available to other than the enrolled learners of the Licensee University.




